**REORGANIZING THE LOCAL CULTURE AND ARTS COUNCIL IN THE
MUNICIPALITY OF SAN VICENTE, ILOCOS SUR**

WHEREAS, Republic Act No. 7356 provides for the creation of the National Commission for Culture and Arts (NCCA), duly mandated to encourage and facilitate the organization of a network of regional and local councils for culture and arts;

WHEREAS, DILG Memorandum Circular No. 2022-81 provides for the creation of Local Culture and Arts Council in order to promote cultural and artistic development, preservation, and conservation of national and local heritage;

WHEREAS, the Municipality of San Vicente, by virtue of Republic Act No. 11645, has been established as heritage zone or an area whose historical and cultural must be protected, as defined and provided for by Article II, Section 3(q) and Article IV, Sections 12 and 13 of Republic Act (RA) No. 10066, otherwise known as the "National Cultural Heritage Act of 2009";

NOW THEREFORE, I, **JONAN D. TABANDA**, Municipal Mayor of San Vicente, Ilocos Sur, by virtue of the powers vested in me by law, do hereby order the reorganization of the Local Culture and Arts Council with the following:

SECTION 2. FUNCTIONS OF THE COMMITTEE. The Committee shall be responsible for the following functions:

1. Prepare an annual plan on culture, arts, and cultural heritage consonant with the Philippine Development Plan for Culture and the Arts, to be integrated into the local development plan and considered in the annual appropriation ordinances;
2. Formulate programs and recommendations to develop and sustain local cultural and artistic talents, cultural industries, traditional and contemporary arts and crafts, and their processes;
3. Coordinate with the appropriate affiliated cultural agencies of the National Commission for Culture and the Arts (NCCA) for the conservation and monitoring of national cultural properties found in the LGU;
4. Conduct cultural events such as cultural festivals, competitions, lectures, seminars, and symposia;
5. Identify such other programs and activities for the promotion of local cultural heritage and arts;
6. Ensure the protection, preservation, conservation, and promotion of the local cultural and historical heritage;
7. Declare and maintain Local Heritage Zone;
8. Establish a Local Registry of Cultural Property;
9. Acknowledge the importance of traditional folk artists as singular conduit between skills of the past and the future;
10. Revitalize a community's artistic tradition, thereby protecting a valuable fact of
11. Philippine culture;
12. Provide mechanisms for identification and assistance for qualified traditional folk artists to transfer their skills to the community; and,
13. Create opportunities for popularizing their works locally.

SECTION 3. EFFECTIVITY. This Order shall take effect immediately.
